2009-2010 BEFORE SCHOOL CHILD CARE – FEE PAYMENT SCHEDULE

**Standard program fees are calculated by \$2.00 per hour, 2.00 hours a day, 5 days a week.

180 days (\$2 per hr.) x 2.00 hr. per day = \$720.00 (Total amount)

*Fee reflected below is the total amount divided into 9 payments

\$25.00 Registration Fee Per Family

* Fees are assessed by multiplying the required per hour of instruction fee by the number of hours of instruction, with the product rounded to the nearest whole dollar. The rounding procedure is based on rounding up where the product is at least \$0.50 and rounding down where the product is less than \$0.50.

**Schools will adjust fee schedule if the After School Child Care hours of operation are not the same as the hours stated above and operate at non-standard hours.

As per School Board Policy, 3411 and the Constitution of the State of Florida, Article VII, Section 10, ALL PAYMENTS MUST BE MADE IN ADVANCE PRIOR TO THE START OF THE ATTENDANCE PERIOD. If fees are not paid by due date, child will be withdrawn from the program. Re-registration may occur if there is space available in the program. All fees must be paid to re-register in the program.

| <u>Pay Period 9</u> | May 11, 2010 – June 9, 2010 (payable by May 10, 2010) | \$80.00 |

REMEMBER, all payments must be made prior to the start of the payment period.

If payment is not made by the due date, the child is withdrawn from the program and a re-registration fee must be paid to re-enter the program. All late fees must be paid before the next payment period.
